
Government Stimulus Funds Could Employ Illegals

As federal stimulus money is being sprinkled around the country, thousands and thousands of illegal aliens may be rejoicing because Democratic Members of Congress blocked efforts to prevent government contracting jobs from being filled by illegal aliens.

Open borders politicians in the Senate and House successfully beat back efforts that would require government contractors being paid with government stimulus funds to use the e-verify database. E-verify is an automated system that validates an employee's eligibility to work in the United States.

"Not requiring the use of e-verify is the same as telling contractors that it is okay to hire illegal aliens," complains U.S. Border Security Council Executive Director Brice Griffin. "This government spending is supposed to help Americans get jobs, not serve as a way to subsidize illegal aliens."

U.S. Senator Jeff Sessions led the charge to prohibit illegal aliens from benefitting from the taxpayers' largesse. "Senator Sessions' efforts were tremendous but he simply didn't have the votes," Griffin explains. "The open borders

More Border Crossers Have Criminal Records

According to the *Sierra Visata Herald* newspaper, more and more illegal aliens being caught and detained along the Arizona-Mexico border have criminal records.

According to the paper, many of these illegals are convicted sex offenders. Oftentimes they have been convicted of sex offenses involving children.

In just one weekend, six illegal aliens were apprehended trying to cross into Arizona who had criminal records for sex offenses.

Officials from the U.S. Border Patrol confirmed that more and more criminals, especially criminals with a history of committing sex crimes, are being caught at the border.

Border Security News in Brief

Murders in Missouri Spark Outrage

The small town of Hannibal, Missouri, the birthplace of Mark Twain, was recently rocked by a double murder committed by an illegal alien. Manuel Cazares pleaded guilty to two charges of second degree murder for killing his girlfriend and an associate. Cazares had multiple run-ins with the law but law enforcement officials state that Cazares never appeared in any government databases as being illegal and he possessed what appeared to be a valid Social Security Card.

Home Depot Battles Day Laborers

Day laborers who congregate outside a Palm Beach, Florida, Home Depot are causing headaches for the store. Workers, many of whom are probably illegal aliens, harass the store's customers in the parking lot in an attempt to convince the shoppers to hire them for the day. The laborers are allowed to stand on the sidewalk outside of the store but often block the store's entrance and spill into the parking lot. The Home Depot called the police 21 times to report the trespassers during the first two months of this year.

Illegal Alien Caught Delivering Mail

Authorities in Yavapai County, Arizona, recently arrested Sigifredo Parra-Reyes for illegally delivering the U.S. mail and for being in the country illegally. Parra-Reyes was helping his girlfriend, a contract worker for the U.S. Postal Service, make her deliveries when a local police officer pulled him over. Reyes attempted to fool the officer by providing three separate fake names before the officer took Reyes into custody. Reyes has reportedly been caught and deported by U.S. immigration authorities twice before.

SNEAK OF THE MONTH: House Speaker Nancy Pelosi

This month's Sneak of the Month award goes to House Speaker Nancy Pelosi for her outrageous comments calling federal immigration officers "un-American" for doing their jobs.

crowd has a lot of support in this current Congress.”

Many employers seeking government contracts also opposed the e-verify provisions. The U.S. Chamber of Commerce even opposed requiring e-verify’s use. “These businesses would rather hire cheap illegal labor than hire Americans,” Griffin explains. “So, without the e-verify requirements, American taxpayers are, in effect, subsidizing illegal immigrants.”

“To make matters worse,” Griffin explains, “the illegal workers often send much of their paychecks back to their home country like Mexico. Their salaries don’t go back into the U.S. economy.

“The Congress might as well be boxing up giant stacks of U.S. currency and mailing them to random addresses in Mexico for

all the good a lot of this stimulus spending will do for Americans,” Griffin explains. “The construction jobs building roads or bridges that the President says are crucial to sparking economic recovery are going to be filled by illegal aliens. That isn’t just wrong. It should be criminal.”

However, thanks to the efforts

of pro-illegal alien legislators in Washington, it really is not.

“Once again the politicians are playing the American people as fools,” Griffin says. “They think that they can have it both ways. On the one hand, they are promising the American people jobs. On the other, they are doing everything in their power to make sure that employers can hire illegal aliens without fear of being caught.

“Thankfully we still have allies in Congress, like Senator Sessions, who are fighting the good fight,” Griffin explains. “They may not have been successful in their efforts, but they did raise the alarm and point out the hypocrisy in Washington. Now there is no hiding the fact that the U.S. Congress is trying to help illegal aliens at the expense of American taxpayers.”

“I suppose these rapists and pedophiles are simply trying to sneak into America to realize the American dream and do the jobs Americans won’t do,” replied U.S. Border Security Council Executive Director Brice Griffin. “After all, that’s what the illegal alien lobby wants us to believe.”

Border authorities believe that the increase in the number of criminals crossing the border is directly related to the growing power and influence of the drug lords in Mexico.

“The drug dealers are sending their violent foot soldiers into the United States,” warns Griffin. “I have been warning our political leaders about this threat for some time now.”

“I suppose these rapists and pedophiles are simply trying to sneak into America to realize the American dream and do the jobs Americans won’t do,” replied U.S. Border Security Council Executive Director Brice Griffin.

The percentage of aliens apprehended along the border who have criminal records is skyrocketing. In the Tucson sector alone, the percentage increased from 11% in 2007 to 16% last year. Border Patrol officials reportedly expect

that number to increase even more this year.

“It would not surprise me that this year in this one area along the border that one out of every five illegal aliens is a violent criminal who is sneaking into America to ply their sick and dangerous trade,” says Griffin. “These are not tomato-pickers or mulch-haulers. These are killers, rapists and child molesters we are letting in. The Border Patrol is doing a good job but even it will admit that it presently can’t catch all these criminals coming into our country. Every single American is in danger because of our open borders.”

Council Takes Amnesty Battle To State Governors

Anticipating a new drive to pass a "Comprehensive Immigration Reform" or "Amnesty" bill this year, the U.S. Border Security Council is launching a massive effort to enlist state governors to oppose the move.

Many state governors are facing massive budget shortfalls and taking care of illegal immigrants is no longer as attractive a policy as it was just a couple of years ago.

In Washington state, for instance, liberal Democrat Governor Christine Gregoire is urging federal immigration officials to deport illegal aliens faster so that her state

doesn't have to take care of them.

Such action could save the state of Washington millions of dollars per year.

The Council believes that cash-strapped governors across the nation might be willing to publicly oppose the latest drive to grant amnesty to illegal aliens.

In the next few weeks, U.S. Border Security Council supporters will be asked to sign a special petition to their state governor demanding that he or she oppose any amnesty bill.
