## Open-Borders Advocate Takes Over Homeland Security

Former Arizona Governor and unapologetic open borders advocate Janet Napolitano has taken the reins at the Department of Homeland Security. However, U.S. Border Security Council President Brice Griffin says not much will change.

"Napolitano is just like her predecessor, Michael Chertoff. She supports an open borders and to heck with security policy towards our southern border," Griffin explains. "As Arizona Governor she lobbied for Amnesty and openly

told her allies in Washington that legalizing millions of illegal aliens was in the Democratic Party's best political interest." Griffin explains. "She's bad news, but so was Chertoff."

Napolitano also openly clashed with law enforcement officials in Arizona who wished to crack down on illegals. "People in Arizona seem to be glad to be rid of Napolitano," Griffin says.

Immediately after being sworn

## Strife in Mexico Now At Civil War Level

Civil strife has become so bad that U.S. Border Security Council Executive Director Brice Griffin says parts of that country are now in a state of civil war.

"Mexico is falling apart. The drug gangs have the federal army on the defensive and civil order is almost impossible to maintain in some of the northern provinces," says Griffin. "It's a nightmare."

In recent months well armed drug gangs have intensified their

efforts to control the U.S.-Mexican border and to destabilize the government. The violence is spilling over into the U.S. and it is getting worse.

In the city of Juarez, the Mayor and other elected leaders have moved to El Paso, Texas, and commute to work from the U.S.

In Texas, some localities are issuing automatic assault rifles to law

# Border Security News in Brief

The amount of money sent back to Mexico by immigrants in the United States fell for the first time ever in 2008. "Remittances," as they are called, plunged 3.6% to \$25 million. Remittances are Mexico's second largest source of income after proceeds from the sale of oil.

Two illegal aliens are being held in St. Louis for allegedly hosting parties in their trailer park home where they plied young girls with alcohol and then raped them. Immigration officials have been notified.

A Forsyth County, Georgia, deputy sheriff recently pled guilty to coercing his illegal alien nanny to work for him without pay. Malika Garrett threatened to turn the nanny over to immigration authorities unless she provided her services free of charge. The nanny is a Muslim woman who escaped from Garrett with the help of a neighbor. No word on whether the nanny will be deported.

In Plainfield, New Jersey, a Hispanic newspaper reports that dozens of illegal immigrants have moved into caves because they cannot afford regular housing. The aliens reportedly call their new home "Devil's Cave." The worsening economy is blamed for their "plight."

In one of his final acts as President, George W. Bush, granted clemency to wrongly-jailed border patrol agents Ramos and Compean. The Mexican government reportedly protested the move and may have been the reason the two heroes didn't receive full pardons.

## SNEAK OF THE MONTH: U.S. Chamber of Commerce

This month's Sneak of the Month award goes to the U.S. Chamber of Commerce for lobbying and getting the Obama administration to relax rules governing government contractors.

Although it probably didn't take much effort, Chamber lobbyists successfully got the the administration to postpone requirements that government contractors use the E-verify system to be sure that all their employees are legally entitled



to work in the United States.

The Chamber claims that verifying employment eligibility is too great a burden on American businesses.

The Chamber has in the past been a vocal supporter of Amnesty for illegal aliens.

enforcement so that officers can defend themselves and hopefully repel any violence coming from across the border.

According to the *Dallas Morning News* newspaper, U.S. intelligence officials have warned American businessmen that they could become targets of the drug gangs if they travel to Mexico.

Mexican drug gangs have reportedly even expanded their operations into the United States as far as South Dakota and Massachusetts.

“The situation in Mexico is out of hand,” says Griffin. “This isn’t simply a controversy over lettuce-pickers. This is a full fledged civil-war that is spilling across our borders. Americans are going to die unless the government acts now and shuts down the border.”

Griffin specifically wants military units to be deployed along the border. “The border patrol

and local cops can’t handle this,” complains Griffin.

“We need infantry, we need tanks, we need combat engineers and we need the resolve to defend ourselves,” Griffin urges.

“America is being invaded not just by welfare-seeking Mexicans, but by heavily armed guerrillas seeking to do to America what they are doing to what is left of the Mexican government.”

into her new post, Secretary Napolitano began lobbying for “comprehensive immigration reform.” which is Washington-speak for a total amnesty for all illegal aliens.

“It’s incredible that this woman who is now in charge of protecting the homeland is making granting amnesty for trespassers her number one priority,” says an exasperated Griffin. “Mexico is coming apart at the seams, terrorists are trying to sneak into the country and kill us all, and Janet Napolitano wants amnesty.”

To her credit, Napolitano did urge then-President Bush to deploy National Guard soldiers to the Arizona border, which Bush did.

“However, I think it is generally accepted that she did that simply as a political ploy to keep Arizona taxpayers from coming after her,” says Griffin. “You don’t hear enough about it but Arizona has a terrible problem with illegals. One law enforcement source has

The Obama administration has had virtually nothing to say publicly about the crisis in Mexico. Secretary of State Hillary Clinton has made it clear that the Middle East will be her main area of concern over the next few months.

Meanwhile Homeland Security Secretary Janet Napolitano is making “comprehensive immigration reform” one of her top priorities.

“Mexico is burning. The Pentagon says its government could collapse completely and the Obama administration doesn’t seem to care,” complains Griffin. “Well, they are going to care when tens of millions of Mexican refugees come pouring across the border, fleeing the new narco-terrorist ruled government of Mexico. The catastrophe that could be will make Hurricane Katrina, the Iraq War, and 9/11 pale by comparison.”

confided in us that Arizona has less control over its border with Mexico than does Texas, California or New Mexico.”

The U.S. Border Security Council will fight Napolitano just as it did with her pro-amnesty predecessor. “We beat Chertoff and defeated Amnesty and we will beat Napolitano,” promises Griffin.

“Everyone simply needs to stay alert and be ready to pound Congress when the next Amnesty vote comes up,” warns Griffin. “This will be a big fight and it will be a close vote, but I am confident we will prevail.”

# President's Illegal Alien Aunt Parties At Inaugural Ball

President Barack Obama's infamous illegal alien aunt was spotted partying at one of her nephew's ritzy inaugural celebrations.

Zeituni Onyango was seen by a reporter for the *Cleveland Plain Dealer* at a ball at the luxurious Renaissance Mayflower Hotel just blocks from the White House.

Onyango is reportedly now living in Ohio after being discovered by reporters living in Massachusetts public housing.

Onyango is from Kenya and has been living in the U.S. illegally after she decided to overstay her visa. She then ignored deportation

orders.

Bush administration officials allegedly issued orders to the Department of Homeland Security

to cease all deportations of visa overstayers during the Presidential campaign in order to save Obama from any embarrassment over his aunt's criminal status.

Onyango reportedly has now asked for political asylum in the United States and has a high powered attorney working her case.

There is no word on how the supposedly indigent Onyango could afford travel, hotel expenses and the \$300 ticket for the inaugural ball. Nor is it clear who is paying her legal fees or whether she even has an illegal job in the United States.
