LeBlanc Promises to Fight Any Bipartisan “Compromise”

U.S. Border Security Council National Spokesman Steve LeBlanc is promising to fight any legislative compromise that includes any type of Amnesty for illegal aliens.

“If it has any language that allows illegal aliens to remain in the United States legally, then we will oppose that legislation,” he says. “America cannot reward these law-breakers at all.”

LeBlanc’s comments come in response to President Obama’s

State of the Union Address in which he pledged to keep working for “Comprehensive Immigration Reform” and was open to compromising with Republicans in order to get an immigration reform bill through Congress.

“If the President wants a legislative accomplishment, then he should drop any notion of passing an Amnesty bill and instead focus on border security,” explains LeBlanc. “We need troops on the

Council Applauds Myrick’s Reintroduction of SEAT Act

The U.S. Border Security Council is applauding Representative Sue Myrick for once again submitting the Secure Education for Americans Today Act (“The SEAT Act” H.R. 310). The bill cuts off federal government funding to institutions of higher learning that knowingly allow illegal aliens to enroll in their schools.

“The battle over illegal alien kids taking advantage of America’s colleges is really heating up and Sue Myrick’s bill is very much

needed,” says Council National Spokesman Steve LeBlanc. “The U.S. Border Security Council will do everything we can to make sure H.R. 310 passes.”

Many U.S. colleges and universities refuse to check whether applicants are legal residents of the United States or are legally allowed to study in this country. That makes them “sanctuary schools” in the eyes of LeBlanc.

Muslim Cleric Arrested Trying to Sneak Across Border

U.S. border authorities recently arrested a controversial Muslim cleric who was deported from Canada to Tunisia three years ago. Said Jaziri was caught trying to sneak into California inside the trunk of a BMW.

Jaziri is the former imam of a Muslim congregation in Montreal. He was hidden inside a car driven by a San Diego-area man who was pulled over by U.S. Border Patrol agents near a casino east of San Diego.

On a Lighter, But Still Serious Note

A young Russian woman who was named 'Norwegian of the Year' and wrote a book about life as an illegal immigrant in Norway, is being thrown out of the country. Madina Salamova, who is better known under her literary pseudonym 'Maria Amelie', moved to Norway in 2003 with her parents after neighboring Finland rejected their asylum claim. Norway rejected their claim, too, but the family somehow evaded deportation until very recently.

Texas Bill Targets Mexican Officials

A Texas bill seeks to prevent foreign consular officials from entering public schools or state universities in order to distribute foreign identification cards or accept applications for such cards.

Under the law, Mexican Consulate staff would not be allowed to go onto a school or college campus to help students with their matricula consular applications. These applications allow illegal immigrants to get Mexican ID cards which are then used to get U.S. government benefits.

SNEAK OF THE MONTH:

Selective Service Director Lawrence Romo

Lawrence Romo, Director of the U.S. Selective Service System is this month's Sneak of the Month. Romo is in charge of administering the program that maintains the records of all able-bodied males in America in case a national emergency requires the reimposition of a military draft. All 18-year old men are required to register.

Under Romo's leadership, the Selective Service System is actively encouraging illegal aliens to register so that they can more easily receive government welfare benefits. The agency posted this announcement on its website:

“ATTENTION,
UNDOCUMENTED MALES
& IMMIGRANT SERVICING
GROUPS!

Selective Service does not collect any information which would indicate whether or not you are undocumented. You want to protect yourself for future U.S. citizenship and other government benefits and programs by registering with Selective Service. Do it today.”

The reason we have a Selective Service System is to raise an army in case of foreign invasion. Sadly, Director Romo is trying to register the invaders rather than trying to protect our country from them!

border, barricades, fences and even land mines,” LeBlanc adds. “Securing our southern border should be Obama’s top priority.”

The President, however, seems determined to get some type of amnesty bill through Congress.

Recently Obama has spoken with Republicans John McCain and Lindsay Graham, presumably about immigration issues. Both Republicans have supported amnesty in the past and the Council believes would be likely to side with the illegal alien lobby again under the right circumstances.

“My guess is the White House will come up with some legislation that seems like a tough border security bill,” predicts LeBlanc. “However, it will also probably include some type of scaled-down Amnesty that might garner some Republican support.”

unfair and illegal for these ‘sanctuary schools’ to be doing this.”

Myrick’s bill would cut off all federal funding to these educational

LeBlanc believes that the American people will not support any type of Amnesty. Even a scaled-down bill that offers Amnesty to a small fraction of the millions of illegals already here will meet significant public opposition.

“If it has any language that allows illegal aliens to remain in the United States legally, we will oppose that legislation,” he says. “America cannot reward these lawbreakers at all.”

“The fact is, the President needs to do something sneaky and underhanded in order to get some House

institutions until such time as the school in question begins verifying the legal status of students who are applying to study there.

“American higher education is chock-full of pro-illegal alien administrators and professors. If they are going to break the law, then there must be a consequence,” LeBlanc warns. “This law will hit them where it hurts. Let illegal aliens in and wave goodbye to federal funds for research, building construction and the like.”

LeBlanc emphasizes that Myrick’s bill is not a cure-all but a good first step. “We shouldn’t even have to check on whether someone applying to college is legally entitled to go to school

Republicans to vote for his version of immigration reform, explains LeBlanc. “A compromise that gets a small but significant number of House Republicans to vote for it might include some tough border security provisions that cover up the Amnesty provisions in the bill. However, we will still oppose it.”

LeBlanc calls this strategy “a bait-and-switch con game” that is designed to pull a fast one on the Amnesty-hating American public.

“We are reviewing every piece of legislation that even remotely has anything to do with immigration” LeBlanc explains. “If it has any language in it that involves extending Amnesty to illegals, then we are more than prepared to call out the bill’s sponsor and fight like crazy to make sure that proposed legislation never, ever comes up for a vote.”

here. However, with millions and millions of illegals running around, every institution in American society must do its part to finally begin to enforce our laws and convince these trespassers to go home,” he says.

According to LeBlanc the U.S. Border Security Council will publicly back the bill and will urge its supporters across the nation to lobby their federal officials to vote for the measure.

Council to Support States in Immigration Battles

The U.S. Border Security Council plans to expand its lobbying efforts beyond Capitol Hill and to the states in support of a growing movement by governors to crack down on illegal aliens.

The Council was a vocal supporter of the popular immigration enforcement law in Arizona last year and even urged its supporters to buy Arizona-made products in support of that states' courageous stand. However, until now, the Council has largely

remained focused on legislation at the federal level.

State governors like Rick Perry in Texas are actively fighting the illegal alien

lobby and need the support of groups like the U.S. Border Security Council.

Perry has proposed legislation that would crack down on Texas' sanctuary cities. In other states, politicians are fighting to ban illegal aliens from attending state universities and, in Virginia, a proposal would require localities to keep detailed records on how much money illegal aliens are costing them.
