LeBlanc Brings Passion, Experience to Council

Steve LeBlanc is looking forward to taking over the newly created position of national spokesman for the U.S. Border Council and is pledging to help the organization fight harder than ever to force Congress to secure the nation's borders.

"I'm very excited about this new position and how the U.S. Border Security Council is growing," says LeBlanc. "I hope to use my military experience and my experience working with non-profit advocacy organizations to help expand the Council's influence."

LeBlanc is an army veteran who served in Operation Desert Storm. He has also worked for a number of non-profit advocacy organizations and is particularly knowledgeable and passionate about the issue of illegal immigration.

"Our wide-open border really is this nation's top national security problem," LeBlanc explains. "My job is to publicize that fact and to fight the illegal alien lobby and its allies in Congress and the Obama Administration who want millions and millions of more illegal aliens to flood our nation."

Feds Must Crack Down On Sanctuary Cities Council Says

"The Federal Government absolutely must crack down on the sanctuary cities," says U.S. Border Security Council spokesman Steve LeBlanc. "The sanctuary cities are out of control and they are destroying this country and the Obama Administration's hypocrisy on this issue is astounding."

In the wake of the passage of Arizona's much-heralded new immigration enforcement law, Presi-

dent Obama is arguing that only the federal government can make immigration law and that states like Arizona that are involving themselves in immigration issues, are overstepping their bounds. However, the President, and most importantly the U.S. Justice Department, has refused to criticize local governments that grant "sanctuary" to illegal immigrants for intruding into the federal government's

jurisdiction.

"The fact is that President Obama is just using this argument to try to stop Arizona's law. He knows states are allowed to enforce federal laws. However, he really doesn't want anyone enforcing the nation's immigration laws. That is why he refuses to go after these cities that are deliberately violating

Napolitano Reneges on Security Promise Again

President Obama's pledge to send 1,200 National Guardsmen to the U.S.-Mexico border still hasn't been met. Last June, Homeland Security Secretary Janet Napolitano pledged that the troops would arrive by August 1st. That deadline wasn't met and Napolitano now says that troops won't arrive at their posts for weeks.

Mexican Government Patrols Staten Island

The Mexican Consulate in New York City recently posted some of its diplomats to Staten Island in order to protect the welfare of "its citizens" in the wake of a number of violent attacks on Hispanics in that borough's neighborhoods.

Meanwhile, violence in Mexico continues to spill across the U.S.-Mexico border.

Groups Protest Using Fingerprints to ID Illegals

Pro-illegal alien groups are protesting the use of fingerprints to verify whether individuals arrested by the police for non-immigration related crimes are in this country legally. Various groups as well as local government officials in Washington, D.C. and San Francisco claim that this process is unfair to immigrants and will make members of the Hispanic community less likely to cooperate with the police.

SNEAK OF THE MONTH: **Federal Appeals Judge Susan Bolton**

Federal Appeals Court Judge Susan Bolton is this month's "Sneak of the Month" for forbidding the most important parts of Arizona's new immigration law from taking effect.

Judge Bolton, an appointee of President Bill Clinton, ruled that the law could not take effect because Arizona was not allowed to enforce immigration laws because that was the federal government's job. (One which the federal

government refuses to do.)

Bolton also ruled that the law was unfair to people suspected of being in this country illegally.

Bolton's ruling was a major victory for the pro-illegal alien lobby and the Obama Administration. However, her ruling will be appealed and the case will likely ultimately be heard by the U.S. Supreme Court.

Council. He will sign letters and emails to the Council's growing list of supporters as well as talk to the media. His credibility as a U.S. Army veteran will help reinforce the Council's credibility on national security issues.

LeBlanc says he has lots of plans for the remainder of this year and 2011. "With control of Congress being up in the air, we have to be somewhat flexible," LeBlanc explains. "However, we know that the Administration and a large number of elected officials from both political parties will continue to fight for open borders for some time to come."

For the next eighteen months, LeBlanc says, the Council will have three main goals.

First, LeBlanc says he wants to

federal immigration laws," explains LeBlanc, "It is way past time for the politicians who run these sanctuary cities to be held to account."

Recently, more and more Republicans and Democrats on Capitol Hill are beginning to question why the sanctuary cities are being allowed to help illegal aliens and some Members are threatening to sue.

"I'm glad this issue is becoming more and more prominent," LeBlanc says. "The U.S. Border Security Council has been lobbying to force the Justice Department to actually indict and prosecute public officials who flout our nation's immigration laws. It seems our efforts to point out the problem of the

stop the drive for an illegal alien amnesty. "We've done a good job holding off the amnesty supporters this year. However, there is still a likely lame-duck session of Congress in December where the open borders crowd could push to pass Amnesty Plus. Also, next year, even if Republicans take control of one or more houses of Congress, I expect President Obama to work with pro-illegal aliens Republicans like John McCain and Lindsay Graham in an effort to pass amnesty.

Next on LeBlanc's list is the issue of physically sealing the border and supporting the brave members of the U.S. Border Patrol, local enforcement and the U.S. military who are struggling to stop the violence along our southern border. "Congress must shut the border down. It must be closed to all illegal activity and in order to do that,

sanctuary cities is now paying off."

The Council plans to redouble its efforts to hold the sanctuary cities accountable in the coming months. "We are preparing to launch another nation-wide petition effort now that this issue is becoming more hot," LeBlanc explains. "Now is the time for the American people to stand up to the elected officials in places like San Francisco, Los Angeles, New York and Boston. It is time to take our country back from these illegal-alien loving fools."

Congress must take a stand, finish the border fence and send more troops," LeBlanc says.

Finally, LeBlanc plans to work harder at getting more states to pass measures like the new Arizona law that allows local law enforcement to check on the legal status of suspected illegal aliens. "Right now 20 states are considering laws like Arizona's. The Council is going to push harder at the state level to make sure that these laws get passed."

Overall, LeBlanc is cautiously optimistic about securing the border and halting the tide of illegal aliens. "The American people want this problem solved and they are tired of politicians pandering to Mexico and the illegal aliens. If we can continue to harness that popular anger, we will succeed on Capitol Hill.

Council Sets Its Sights on Senate in Effort to Stop Amnesty Plus

The U.S. Border Security Council is launching a new national effort to stop the U.S. Congress from passing Amnesty Plus.

Council strategists are more and more optimistic that an even more radical version of a blanket immigration amnesty, called Amnesty Plus, can be stopped in the House of Representatives this year.

However, the Senate may very well take up the measure during a lame duck session in December. Momentum behind the bill could then propel

it to passage in the House before a new Congress could take office in January.

A lame duck session is when Congress convenes imme-

diately after an election and allows members who were defeated at the polls to vote on legislation.

The new campaign is being mailed to Council supporters across the nation and includes two personalized petitions to each recipients U.S. Senators.

The Council urges every one of its supporters to sign and return the petitions without delay. The Senate could quickly convene after the election specifically to vote on this measure.
