Illegal Alien Granted Law License by the California Supreme Court In Unanimous Ruling

Want to practice law in the United States but you are not a citizen? No problem, says the California Supreme Court, which recently granted Sergio Garcia, a man living in the US illegally, his law license after passing the state bar exam. Smuggled into the country by his father twenty years ago, Sergio challenged a 1996 law barring illegal immigrants from receiving professional licenses from the state and won. California Governor Jerry Brown immediately signed a law that author-

ized illegal aliens to practice law.

How is an illegal alien expected to uphold the laws of the United States when his presence in the country is in direct violation of the law of the land? For more than twenty years, Garcia has deceived the U.S. Justice system on a daily basis and now he is expected to show respect for our courts?

According to the California Supreme Court, "Under these circumstances, we

“From my meeting with Ms. Tallent in Speaker Boehner’s office, the Speaker does not support amnesty,” states Ferritor. “In fact, it’s the opposite. I know the Speaker’s phones have been ringing off the wall from people categorically opposed to any form of Amnesty. Our members share the same belief,” Ferritor continued.

The Council’s supporters applaud the Republican Leadership’s effort to secure our border, and while Mr. Ferritor made it clear to the Speaker that we may not always agree on every issue, our supporters are 100% behind his efforts to secure the borders; so the Council looks forward to working with the Speaker on that issue.

conclude that the fact that an undocumented immigrant's presence in this country violates federal statutes is not itself a sufficient or persuasive basis for denying undocumented immigrants, as a class, admission to the State Bar."

This is a gross violation of the American

public's trust in our justice system and should be immediately revoked. For allowing politics to cloud their judgment and threaten the very tenets of our court system, Chief Justice Tani Cantil-Sakauye and the California Supreme Court are our Sneak of the Month.
