U.S. Border Security Council National Spokesman Steven J. LeBlanc visited Capitol Hill recently to attend a hearing held jointly by the Committee on Science, Space, and Technology, Subcommittees on Research and Technology, and Subcommittee on Oversight, titled “Technology Needed to Secure America’s Border.”

“The thing that stood out to me was how many times the witnesses either dodged a direct question, or simply could not produce an adequate response to the Subcommittee’s inquiries,” stated LeBlanc. “I was there to

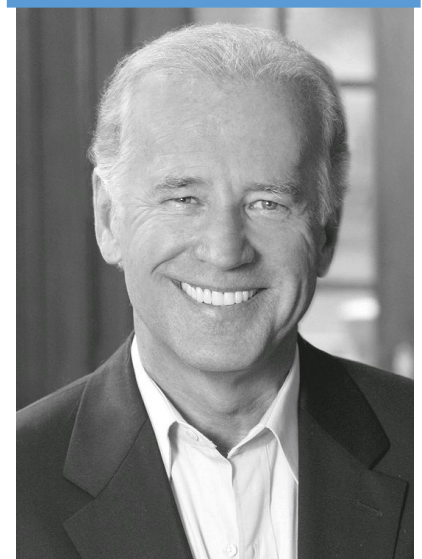

learn more about how our members and supporters could help this country secure our nation's borders, not watch a dog and pony show."

Chairman Bucshon from the Subcommittee on Science and Technology, as well as Chairman Broun from Oversight, continually pressed the witnesses on why modern technology, such as infrared lasers, isn't being utilized on our southern border. To which Dr. Jack Riley, Vice President of RAND National Security Research Division answered, "We need to

assess programs we already have before spending more on new technology."

"Honestly, it was hard to fathom what I heard today" continued LeBlanc. "Chairman Bucshon announced that there will be a follow up hearing in September to grill the Department of Homeland Security on the issue further, and I, as well as every member and supporter of the U.S. Border Security Council, deserve an explanation for the current state of our southern border."
