“Children from Central America are still being coerced and coached to risk their lives to get to the United States so that their parents can be admitted and skirt the immigration process,” states LeBlanc. “Congressman Randy Weber has written legislation that can help stop the problem at its roots, by cutting funding to the Central American nations that aren’t doing enough to curb their citizens’ mass exodus through Mexico and into America.”

The U.S. Border Security Council met recently with the staff of Congressman Weber to encourage the bill’s reintroduction. “We’ve been assured that this bill will, indeed, be reintroduced,” states LeBlanc. “We now need your help to ensure that our survey and petition drives get the attention on Capitol Hill they deserve.”
